AGREEMENT

The information provided through this service is confidential to the participants and law enforcement agencies.

Upon execution of this agreement and payment of the annual subscription fee You and your employees may access and use the Alert Service for your benefit. This subscription does not grant You any right to distribute, sell, make available, disclose, or otherwise transfer information obtained from the Alert Service to any third-party.

Following any breach of this agreement, EPCOR may revoke Your subscription at any time. Unless the subscription is renewed on terms agreeable to You and EPCOR, You cannot access the Alert service after Your subscription expires or is revoked. If Your EPCOR membership is terminated for any reason access to the Alert Service will be automatically revoked.

You agree that EPCOR may independently act to remedy any breach, including for example revoking, restricting, or otherwise censoring Your membership rights and privileges.

You further agree that Your access and use of the Alert Service is at Your sole risk, and that EPCOR makes no warranties of any kind, expressed or implied, and disclaims all expressed, implied, and statutory warranties and conditions. You also agree that EPCOR will not be liable for any indirect, special, incidental, or consequential damages. EPCOR’s total liability shall be limited to the subscription fee paid by You.
